General Terms & Conditions:-

- I. The bidders should be registered with FBR and reflected on active tax payer list.
- II. All the bidders should also be registered with KP Revenue Authority (KPRA).
- III. In case of bid/rate quoted by the bidder more than 10% below engineer estimate, the additional bid security shall be required from the successful bidder **only** to the extent of bid more than 10% below the engineer estimate in the form of % age.
- IV. The framework contract will be valid up to 30-06-2021.
- V. Incomplete, Conditional and Bids without Bid Security i.e Rs. 150,000/- shall be considered as non-responsive.
