TERMS AND CONDITIONS

1. Tender Form/ BOQ can be downloaded after publication in the newspapers from Local Council Board website (www.lgkp.gov.pk).
2. Option of printing of tender will be visible only to the enlisted Contractors / Firms on provide online the bid in percentage of above / below along with amount, bank and date of earnest money.
3. All the Contractors / Firms have an option to withdraw their bids online upto closing time of tender if they intend not to participate and bidding, in case they have applied rates online then they shall be compelled to submit printed tender's documents along with requisite documents to Tehsil Municipal Administration Takht Bhai, otherwise will be liable to be declared as black listed as per notification AOI/LCB/19-6-2017, dated 19-06-2017.
4. Any tender or offer of works made by any Contractor / Firms without filling bids online shall be null and void henceforth.
5. Contractors must follow the new provincial government rules/instruction under the Notification NO.SO-IV/CMS/KPK//1-13/2016/4264-70 dated 08-04-2016 keeping in view the mentioned notification the contractors shall quote their rate "ONLINE" as above/Below. All Contractor /firms are bound to follow the KPPRA rules to.
6. Complete bids both Original & Duplicate Tender Form along with other documentation i.e. Original CDR, Copay of CNIC, Local Council Board enlistment/registration, Pakistan Engineering council registration, KPPRA registration, Power of Attorney (if applicable), Form-H, should be reached to the office of Tehsil Municipal Administration Takht Bhai through Courier/registered mail services on fixed date & time.
7. **Reference to Notification No. S.R.O (14)/Voil: 1-24/2021-22, dated 10-05-2022.**
 - i- Contractor quote their bids upto a limit of 10% below shall submit bid security to the extent of @2% of Engineering estimate only.
 - ii- The contractors quoting their bids more than 10% below upto 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to @2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as NON-RESPONSIVE and the 2% bid security shall be forfeited in favour of government and the second lowest bidder and so on will be considered accordingly.
 - iii- Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on engineers estimated cost equal to the differential amount of submitted bid and engineers estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as NON-RESPONSIVE, all the securities submitted along with such NON-RESPONSIVE bid shall be forfeited in favour of government and the 2nd lowest bidder and so on will be considered accordingly.
8. Any bidder who provided incorrect information shall be disqualified.
9. In case of bids became tie the award of contract shall be decided through new E-toss system.
10. Department will not be bound to provide any machinery/Testing Laboratory its expenses
