NOTICE INVITING E-TENDER

1. **Peshawar Development Authority** invites sealed bids from eligible firms/companies for “**Skill/Unskilled Man Power Service for Water Supply Hayatabad**”
2. Registered firms / Companies shall be selected through an open competitive bidding process of **single stage two envelope** procedure in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules 2014 under Rules 14 (2) b on item rate basis.
3. 2% (Two percent) **Bid Security/Earnest Money** must be accompanied in shape of Call Deposit in the name of Director General, Peshawar Development Authority Peshawar from scheduled Bank.
4. An affidavit is required to be provided with the Technical bid that 2% Bid Security without mentioning amount is attached with the Financial Bid.
5. Tender form and Standard Bidding Document consisting of complete specifications, Bill of Quantities (BOQs), ITBs and standard set of contract conditions can be downloaded from Peshawar Development Authority (PDA) website . www.pda.gkp.pk, one day prior to the opening date.
6. The Tender Documents fees Rs.5000/-(Non-refundable) shall be payable through Demand Draft of Pay Order in the name of Director General, Peshawar Development Authority Peshawar.
7. The Technical and Financial proposals/Bids shall be placed in separate envelope and then placed in a single sealed envelope clearly mentioned name of work on envelope and addressed & sent to the undersigned through Registered Courier Service **on or before 27.06.2024 up to 11.00 AM**. The bids received by hand and or late shall not be entertained.
8. The Bids will be opened in the office of the Procurement Wing, PDA **on 27.06.2024 at 12.00 Noon**
9. The Firms/companies must have active income tax registration and active General Sales Tax Registration with FBR and must be registered with Khyber Pakhtunkhwa Revenue Authority/Relevant Provincial Sales Tax Authorities.
10. A pre-bid meeting will be held with the interested bidders **on 24.06.2024 at 2.00 PM** in the office of Director (Water & Sanitation) PDA, PDA House Commercial Complex Block-2 3rd Floor, Phase-V Hayatabad Peshawar.
11. All federal and provincial duties / stamp duty / taxes including sales tax will be recoverable as per directives of the government issued from time to time.
12. The submission of Bids by the firms/companies implies that they are fully conversant with the nature of work, scope of work and terms conditions laid down in the tender/Bid documents.
13. Any disfiguring / over writing, manipulation in the tender / BOQ shall be liable to rejection. Incomplete / conditional bids shall not be acceptable.
14. The undersigned reserves the right to reject any or all bids as per provisions contained in Rule 47 of KPPRA Procurement Rules 2014.
