KPRA (Active), affidavit of never been blacklisted / No litigation by the government / Semi-Government or any Autonomous Body, etc. on EPADS as per the required criteria
- 3. 2% (two percent) earnest money / bid security of the Engineer Cost Estimate must be submitted in the shape of Call Deposit in name of the Director General, Peshawar Development Authority Peshawar, (if any).

  4. Matters pertaining to additional titles and the content of the Engineer Cost Estimate must be submitted in from scheduled banks in accordance with the Rule 20(2) of KPPRA Rules 2014 and subsequent amendments.

- Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS 2025 1st Bi-annual / prevailing market rates (NSI) with the approval of the Competent Authority.
- All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
- The procuring entity may reject all bids or any proposal / Bid at any time prior to the acceptance of a bid or proposals.
