


## NOTICE INVITING TENDERS/BIDS

Public Health Engineering (PHE) Division-I, Peshawar, Government of Khyber Pakhtunkhwa, invites bids through EPADS, for the following works, from the eligible bidders in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 on single stage two envelopes procedure.

### Terms and Conditions:

1. Bid Solicitation Documents (BSD) which includes Bidding or Contract Data, Bill of Quantity (BOQ) & Criteria for Basic Eligibility / Bid Evaluation, can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. Bidder(s) shall submit/upload their bid(s) [by file uploading] through EPADS before last date and time for submission of bid.
3. Bidder(s) shall submit, in a separate sealed envelope, their work-wise original bid security instrument, in the shape of call deposit receipt (CDR) made in favour of the undersigned, in the office of the undersigned through registered post/courier before last date and time for bid submission. This sealed envelope shall be opened at the time of Financial Bid Opening.
4. The interested bidder shall also submit, in a separate sealed envelope, work-wise (individually) non-refundable bidding document fees i.e., Rs. 2,000 in the shape of call deposit receipt made in favour of the undersigned through registered post/courier before last date and time for bid submission. This sealed envelope shall be opened at the time of Technical Bid Opening. In case of bidder(s) fails to submit the said non-fundable fee, their bid(s) shall be considered as 'non-responsive or technically unqualified'.
5. The received bid(s) shall be opened (downloaded from EPADS) on/after the date and time of technical bid opening in the presence of bidders or their representatives who opt to be present.
6. The received bid(s) shall be evaluated as per the basic eligibility criteria mentioned in the bid solicitation documents.
7. The content of bids, uploaded by the bidders on EPADS, shall be readable. In case of non-readable or blurred documents uploaded by the bidders, the bids shall be rejected and considered as non-responsive.
8. The bidders shall submit their bids as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
9. KP-PPRA's Notification No. S.R.O.(29)/Vol:1-40/2025-26/699-711 dated 29/10/2025 shall be applicable.
10. If any clarification/query is sought by any bidder, the bidder may communicate through EPADS.
11. The scope, estimated cost, work-wise bill of quantities and other details of the works are mentioned in the BSD.
12. Bidders shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) with active status.
13. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
