The bidders shall upload all the mandatory and relevant documents along with the bid security on the EPADS. Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.

The bidders are required to submit only bid security (in original) and physical form in the form of Call Deposit Receipt (CDR) / Demand Draft (DD) / Pay Order or Banker's cheque in the name of 'Principal GDC TakhtBhai Mardan'.

Rates must be inclusive of all applicable taxes; deductions will be made as per law. Imported items must be supported with relevant documents; only genuine/original brands will be accepted.
