(23)/Vol: 1-34/2024-25 dated March 24, 2025; DHQ Teaching Hospital KDA Kohat intends to invite e-bids through E-Pak Acquisition and Disposal System (E-PADS), from firms/vendors/suppliers registered with Income Tax and Sales Tax Department, for the procurement of the following items for the fiscal year 2026-2027. The procurement shall be carried out in accordance with Rule 6(2)(a) under the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement Rules, 2014.



Terms and Conditions:

1. E-Bids, prepared in accordance to the instructions contained in the bidding documents along with bid security instrument, and required documents; must be submitted by using E-PADS on or before JUNE 25, 2026 till 11:00 am. Manual bids shall not be accepted. Electronic Bids will be opened on the same day at 12:00 pm.
2. Scanned copies of all documents shall be uploaded through E-PADS while submitting e-bid. However, bid security instrument in form of Call Deposit Receipt (in original) shall also be submitted in the office of the Medical Superintendent DHQ Teaching Hospital KDA Kohat, before closing time for submission of e-bid.
3. The approved rates will remain valid until June 30, 2027, under KPPRA Rule 31(A) pertaining to framework contracts/agreements.
4. Bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) for works/services.
5. The competent authority reserves the right to reject all bids or proposals at any time prior to the acceptance as provided under Rule 47 of the KPPRA Procurement Rules, 2014.
