1. Bid Solicitation Documents (BSD) Bidding or Contract Data/ Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA (kppra.gov.pk).
2. Last date & time of submission of the CDR/Bid is **15-06-2026 at 12: Noon** and Opening Date same **at 12:30 P.M** in the present of contractors or their representatives, who opt to.
3. The bidder should submit bidding documents.
 - a. Enlistment of C&W Department Smart Card/PEC updated.
 - b. Documents showing general capabilities, financial soundness, general and relevant experience record personal capabilities, equipment capabilities and income Tax/NTN certificate etc.
 - c. Any other documents to support the technical bid.
4. "Bid Security & Additional Security is required to be deposited as per KPPRA Notification bearing No. S.R.O (14)/Vol: 1-24/2021-22 dated the 10th May, 2022/6058-71"
5. Bid entry fee@ 0.03% of tender cost should be submitted separately in the form of CDR (non-refundable). if the contractors are not attached tender form fee the bidder is non responsive.
6. All contractors are directed to provide their vendor numbers in the office of undersigned.
7. In case of more than one successful bidder having same rates, the decision will be made on toss in the presence of contractors/representatives.
8. Only pre-qualified, standardized firms registered with PHED KPK are eligible for participation in the tender of pumping machinery at S.No.2.
9. The Call Deposits/Additional Security of all the contractors will be retained till approval of the tenders by the tender approving authority.
10. Any cutting/over-writing on the BOQ will be liable to rejection of the tender and will be declared non-responsive.
11. The Bidders are required to send their Bids through Courier Service and the bids shall reach the Offices before the closing date and time.
12. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No.XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act bid.
13. As per KPPRA Notification No. SRO (29)/Vol:1-40/2025-26/699-711 dated 29-10-2025, failure to submit original bid security and additional security within the stipulated time shall result in debarment for one (01) year. In case of a second violation, the bidder shall be blacklisted for a minimum period of three (03) years in accordance with section 29 of KPPRA Act read with rule 44 of the KPPRA rules,2014.
14. In case if the Government announces public holiday on the opening date of tender the same shall be opened on next working day at the same time.
