The Excise Taxation and Narcotics Control Department, Khyber Pakhtunkhwa Peshawar hereby invited quotations under ADP No.220842 “ GIS based Property Tax Survey in District Charsada, Swabi, Mansehra and Haripur on the **basis of Single Stage Single Envelop procedure** through EPADs from eligible bidders for the supply of IT and allied equipment.
2. Interested eligible bidders can download Bid documents from <https://kp.eprocure.gov.pk> and after publishing of NIT. Bid documents will be filled neatly and a clear scan copy of the same will be uploaded at the time of applying (bid submission) through EPADs.
3. While Original Bidding documents along with Original 02% Bid security of the total quoted amount in the form of (Demand Draft/Banker Cheque / CDR in the Name of **Additional Secretary** Excise Taxation & Narcotic Department) complete in all respect must be delivered through courier to the office of **Additional Secretary** Excise Taxation & Narcotic Control Department, Abdul wali Khan Blok-C, Civil Secretariat, Peshawar on or before **11.30 AM, 21st September, 2026**.
4. The Firms/ contractors who want to participate in tendering process may register themselves with the EPADs for gaining their unique username and password.
5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are in strict compliance with the provisions of the Khyber Pakhtunkhwa Public Procurement Act and its Rules made there under.
6. Bids will be opened in the presence of bidders’ representatives who choose to attend on **21st September, 2026 at 12:00 PM** in the Committee Room of Excise Taxation and Narcotics Control Department, Civil Secretariat, Peshawar, Khyber Pakhtunkhwa.
7. Pre-bid meeting will be held on 09th September, 2026 at 11.00 am, In the committee room of ET&NC department.
8. The bidders are requested to give their best and final prices inclusive of all taxes / levies as no negotiations will be entertained.
9. The bidder who does not fulfill the eligibility criteria, their bids shall be considered as non-responsive and shall not be included in further process.
10. Bidders should be registered entities with the Government under one of the Federal or Provincial Registration Acts.
11. Bidder must be income tax and sales tax registered and must be on active tax payers list of FBR carrying a National Tax Number (NTN).
12. Bidder Shall provide Undertaking on letterhead to supply the items having online verifiable part numbers.
13. The bidder should have local office and after sale services in Peshawar.
14. Bidder shall provide the item / items within the time specified in schedule of requirement.
15. Bidder shall provide on a stamp paper an Affidavit stating that the proponent has never been blacklisted / Bankrupted by any government / semi-government organizations (procuring entity) under the administrative control of the Federal / Provincial governments and that no litigations underway against them.
16. In case of providing false information, the bid security shall be forfeited and the firm shall be blacklisted/debarred in accordance with the prevailing rules and policy.

17. Contract / Purchase order will be awarded to the lowest eligible / qualified bidder fulfilling the criteria mentioned above and all the terms and conditions of the BSD.
18. Excise Taxation and Narcotics Control Department (ETNCD) has the right to accept or reject any or all offers as per procedure mentioned in KPPRA Rules, 2014.
