1. A complete set of bids Solicitation Documents (i/c Tender Form, Instruction to the Bidders, BOQ, and Criteria etc.) shall be downloaded from the official website of E-Pak Acquisition and Disposal System (EPADS of PPRA) at (<https://epa.ppraprovider.gov.pk>).
2. Interested bidders must submit their Bid via E-PADS (Scan Copy) and original Bid (Hard copy) submitted in two sealed envelopes separately marked as technical and financial Bids with single outer envelope which must reach the office of the undersigned through register courier service before closing time and date mentioned above.
3. The bid security in the shape of CDR from any schedule bank/branches in Pakistan in the favor of DIG Finance & Procurement, Peshawar must be attached, with the technical bid and scanned copy be uploaded on PPRA-EPADS and original be submitted in sealed envelope along with Technical Bid.
4. The bidders should submit "Additional Bid Security" as per KPPRA Notification. (Updated).
5. The bidders are required to quote rates above or below on both MRS as well as on non MRS items.
6. The bidders who are failing to submit their bids through both (soft and hard) shall be declared non-responsive and their bids shall not be considered for evaluation. Technical evaluation will be carried out in the office of Chairman Procurement Committee on the basis technical evaluation criteria given in bid solicitation document.
7. Bidders are advised to carry out a site visit to obtain first-hand information regarding site conditions before submitting their bid.
8. Bids received through hand/fax/telephone/email would not be entertained.
9. Any electronic bidders who submit fake or forged documents or information shall stand De-Barred.
10. In case of material deviation or change between the hard and soft copies of the bid, the bid shall be deemed rejected and non-responsive.
11. In case of any unforeseen reasons, public holidays, unrest or force majeure on the bid submission /opening date, the bid shall be opened on next working day at the same place and time.
12. Interested bidders can obtain any further information /clarification from the office of SP Admin CPO Peshawar, Khyber Pakhtunkhwa Police.
13. The procuring entity may reject all bids at any time prior to the acceptance of a bid. The procurement entity shall upon request communicate to any contractor who submitted a bid, the ground for rejection of all bids as per KPPRA Rules 47(1). NIT is also available on the following websites:
