NOTICE FOR INVITING BIDS THROUGH EPADS

Tehsil Municipal Administration (TMA) Nowshera, Government of Khyber Pakhtunkhwa, hereby invites online electronic bids from eligible firms / suppliers / contractors registered with Pakistan Engineering Council (PEC) for the current financial year in the appropriate category with relevant Specialization Code(s) **ME07: General Mechanical Works** and **ME04: Heavy Machinery, Cranes & Workshop Equipment**, Khyber Pakhtunkhwa Revenue Authority (KPRA), Federal Board of Revenue (FBR) in Active Taxpayer List (ATL), and active enlistment with Local Council Board (LCB) Khyber Pakhtunkhwa, in accordance with Khyber Pakhtunkhwa Public Procurement Rules, 2014 (as amended), under **Single Stage Single Envelope procedure** through the E-PAK Acquisition and Disposal System (EPADS) portal (www.eprocure.gov.pk) for the execution/supply of following works, **(out of District Fund)**.

TERMS & CONDITIONS

1. Bid Solicitation Documents can be download from the EPADS website (www.eprocure.gov.pk) before the closing date and time.
2. Last date & time for submission of bids is **19/10/2026 at 12:30 PM**.
3. The bids will be opened at **01:30 PM** on **19/10/2026** in the presence of procurement committee, and the bidders or their authorized representatives.
4. The Bidders shall submit their bids through EPADS as well as submit a hard copy in a sealed envelope. The hard copy of the bid must be sent to the **office of the Tehsil Municipal Administration, Karimi Stop GT Road, Nowshera**, through registered courier service before the bid submission due Date/time.
5. The bids must be accompanied by a Bid Security equal to Rs. @ 2% of total Estimated Cost of the project in the shape of CDR on the name of TMO, TMA Nowshera.
6. The bidders shall also submit their Bids (Hard Copy) with requisite documents i-e: - E-Tender Form, Signed BOQ, Active NTN Income Tax Certificate, PEC, LCB & KPRA Registration (Active), 2% earnest money, additional security if any (original in shape of CDR) & a certificate to the effect that there is no dispute of the Firm with any department involved litigation/arbitration on the left over incomplete projects and blacklisting on Stamp paper to the office of the undersigned through Registered Courier Service before the closing time.
7. Matters related to the retaining of Bid Securities and failure to submit Bid Security & Additional Security shall be dealt with in accordance with KPPRA Notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022.
8. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bids as non-responsive without any forfeiture of bid securities and record reason thereof.

the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through Toss/draw.

10. Bid will be valid for 90 days from the date of bid opening.
11. The contractors/firms will have to start work immediately after the issuance of work orders, otherwise their call deposits will be forfeited and will not be allowed to participate in any tendering process.
12. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the person signing the bid.
13. All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
14. All bidders shall enter the details of the bid security and where applicable, the additional security instrument in the E-PAK Acquisition and Disposal System (EPADS) at the time of bid submission. The original bid security and additional security instruments, details of which have already been entered in EPADS, shall be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instruments of all bidders until signing of the contract with the best evaluated bidder or till the bid validity period whichever is earlier.
15. Non-refundable Tender fee @ 0.03% of the estimated cost shall be submitted with bids in the shape of call deposit (in original) in the name of the **Tehsil Municipal Officer, Tehsil Municipal Administration, Nowshera** along with the stamp duty.
16. Clarifications/queries may be asked/communicated through EPADS.
17. The bid security shall be in the form of a Call Deposit in favor of the **Tehsil Municipal Officer, Tehsil Municipal Administration, Nowshera**.
18. Any cutting/overwriting on the tender form/BOQ shall be liable to rejection of the tenders and will be declared as non-responsive.
19. The bidder/Firm should provide all relevant attested documents of their registration.
20. The competent authority reserves the right to accept or reject any or all bids under Rule 47(1) of KPPRA Rules, 2014.
21. All the prevailing KPPRA rules / Act and other Govt: notifications issued from time to time shall be applicable.
