

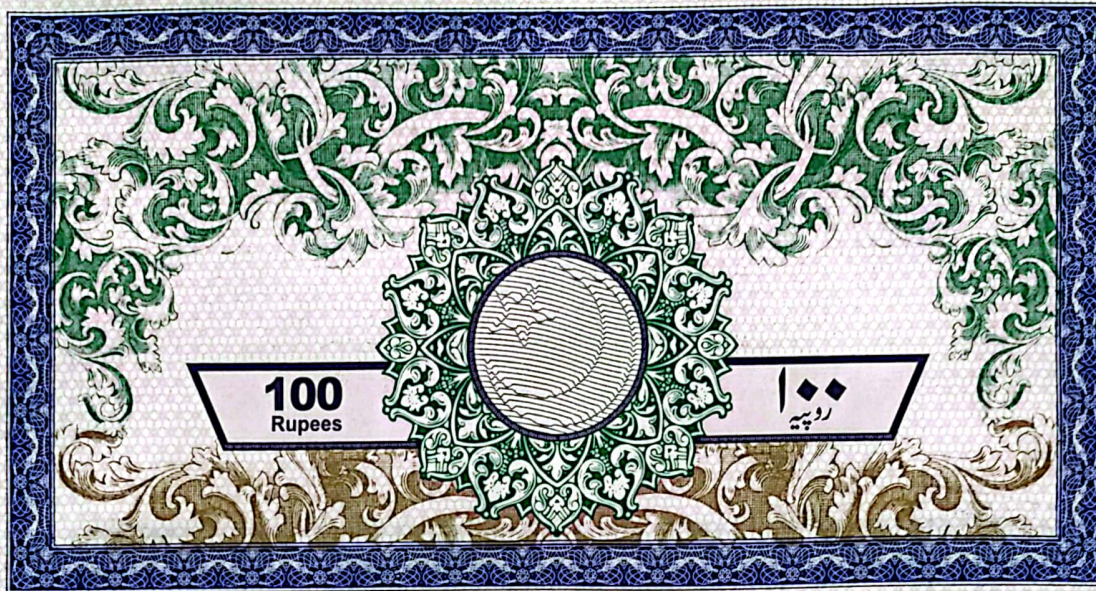

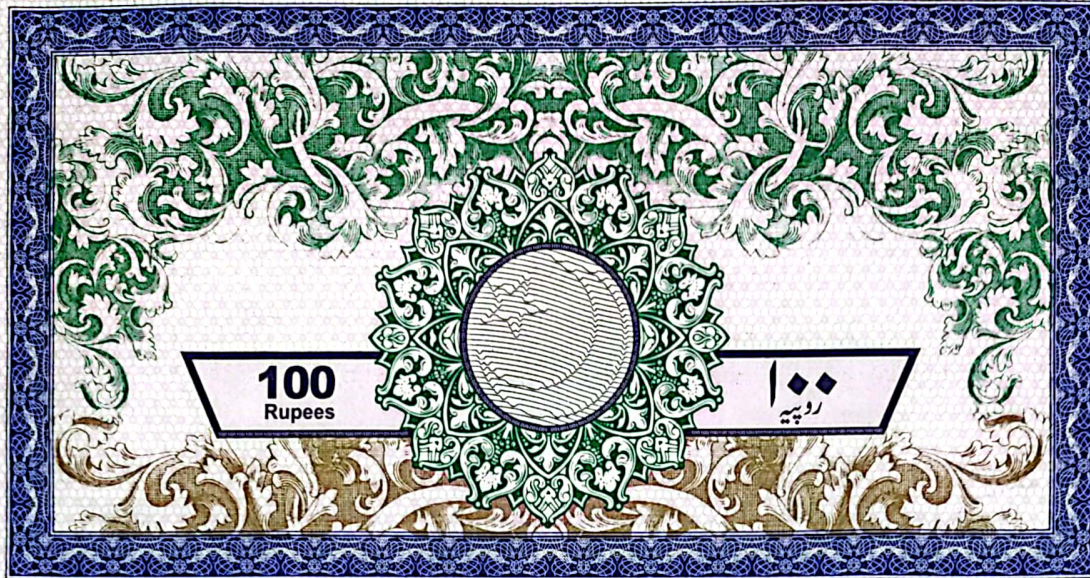

9. The Khyber Pakhtunkhwa, Culture and Tourism Authority as the case may be, and the M/s 86 Production shall make every effort to resolve amicably by direct negotiation, any disagreement or dispute arising between them under or in connection with the services provider. However, despite such negotiation if the Khyber Pakhtunkhwa, Culture and Tourism Authority and M/s 86 Production have been unable to resolve amicably a contract dispute, either party may refer the case to Secretary to The Government of Khyber Pakhtunkhwa Department of Tourism, Culture, Archaeology & Museums for decision and shall be settled through arbitration under the Arbitration Act of 1940 (As amended from time to time).

10. The Procuring Entity may at any time terminate the Contract by giving written notice of one month time to the Bidder if the Bidder becomes bankrupt or otherwise insolvent. In this event, termination shall be without compensation to the Bidder, provided that such termination shall not prejudice or affect any right of action or remedy which has accrued or shall accrue thereafter to the Parties.

11. In case M/s 86 Production repudiates the contract or fails to furnish performance and as the case may be the Procuring Entity shall proceed for debarment or blacklisting of the bidder and call deposit/ bank Guarantee of the firm will be forfeited.

12. The KPCTA may terminate this Contract, by not less than thirty (30) days' written notice of termination to the Service Provider, to be given after the occurrence of any of the events specified in paragraphs (a) through (d) of this

13. In case of event cancellation or postponed the procurement entity is legally responsible to provide timely written notification to M/s 86 production at least 48 hours prior to the schedule occurrence. In such timely information the procuring entity shall be exempted from any financial obligation otherwise.
